NICHOLSON GRIBBIN

RECORDS

Nicholson Gribbin was an early Auckland legal firm which changed its name to **Phillips Nicholson** and at present (1993) practices under the name of **Phillips Fox**. The collection includes approximately 3600 legal deeds (chiefly conveyance and probate) as well as ledgers, files, registers and financial records, housed in 48 boxes. The collection is arranged according to Phillips Nicholson's own system (PN numbers). **Box 1 to 29, and 47 to 48** contain the deeds and **Box 30 to 46** contain the ledgers, registers and financial records in bound volumes. An alphabetical index of clients' names with a brief description of the type of document and date is provided. To find a particular client's document(s), look up the client's name in the index for the PN number and check the PN number against the box number, for example :

- * the documents for Abbott, F M are in PN 1 which is housed in Box 1, and
- * the documents for Abbott, L S are in PN 2380 which is housed in Box 27.
